

**The Trade Competition Commission**  
**Regulation on**  
**The Payment of Remuneration, Accommodation and Transportation Expenses**  
**for Witness and Expert Witness**  
**(No. 2)**  
**B.E. 2564 (2021)**

Whereas it is necessary to amend the Regulation on the Payment of Remuneration, Accommodation and Transportation Expenses for Witness and Expert Witness B.E. 2563 (2020) to be more appropriate and conforming to current circumstances;

By virtue of Section 17 (14) of the Trade Competition Act B.E. 2560, together with the Resolution of the Trade Competition Commission on its meeting session 43/2564 on 11 November 2021, the Trade Competition Commission hereby issues the Regulation as follows.

Article 1: This Regulation is entitled “The Trade Competition Commission Regulation on the Payment of Remuneration, Accommodation and Transportation Expenses for Witness and Expert Witness (No. 2) B.E. 2564 (2021).”

Article 2: This Regulation shall be effective on the following day after the date of being published in the Government Gazette onwards.

Article 3: The definition of “Expert Witness” in Article 3 of the Regulation on the Payment of Remuneration, Accommodation and Transportation Expenses for Witness and Expert Witness B.E. 2563 (2020) shall be annulled and being replaced by the following:

““Expert Witness” means a person with highly-regarded qualification, knowledge and expertise, or experience in any particular field of specialization that the Commission, the Sub-Committee appointed by the Commission, or the Secretary have requested, in writing, to give a statement or opinion in relation to the proceeding of criminal or administrative litigation, regardless whether such statement or opinion was given verbally or in writing.”;

Article 4: The schedule of rates for remuneration and accommodation expense for witness and expert witness attached to the Regulation on the Payment of Remuneration, Accommodation
